APPLICATION FOR “SPRINKLER/NOVELTY SALES PERMIT

1. Application for a permit must be filed at least thirty (30) days prior to the beginning for designated permit period.
2. A separate permit application is required for each sale, storage, and handling site. Permits shall be non-transferable.
3. Find approval for any permit is subject to an on-site inspection by the Fire Chief or designee.
4. The permit issued shall be posted conspicuously at the approval site location.
5. The Fire Chief or designee shall have the right to deny or revoke any permit, at any time, for any unsafe conditions or acts, or non-compliance of any provisions of the applicable codes.

- C.** You must attach an approved site plan with this application containing the following:
- (1) Location and description of required fire protection equipment and **”NO SMOKING”** signs.
 - (2) Location of storage area and/or storage containers on site.
 - (3) Location and description of electrical equipment and/or generators and associated wiring used at the site.
 - (4) The site plan shall include the sales area configuration, including exits/exit access throughout interior of sales, storage and/or handling sites.
 - (5) For outdoor sites, the site plan shall include exact distances from all structures, roadways and fuel storage or dispensing areas.
- D.** You must submit a written, notarized permission from the property owner or authorized agent for the site location.
- E.** You must submit proof of public premises liability insurance, in the amount of three hundred thousand dollars (\$300,000), naming the **“City of Hollywood”** as additional insured of the policy.
- F.** You must attach a copy of a valid State Fire Marshal’s Office License approving applicant as a **“Florida Seasonal Retailer”** or **“Retailer”** as defined in F.S. 791.
- G.** You must provide an inventory list of all items proposed for sale, storage, and/or handling at the site location, including the quantity of each, in compliance with the State Fire Marshal’s Office **“Approved Sparklers List”**, as specified in F.S. 791. Please attach to application.
